

Fund Manager's Comment

On March 2021, Jakarta Composite Index (JCI) closed down -256.3 points (-4.1%) to 5,985.5 level. The leaders were TPIA, ARTO, SMMA, CPIN, and BMRI while the laggards were BBCA, BBRI, BRIS, MAYA, and INCO. During this month, the market recorded net foreign sell of -IDR2.4T. From the commodity market, oil price slipped and traded at level USD59.2/barrel while gold price remained flat at USD1,714/ounce. Rupiah exchange rate weakened by 2.0% during the month and closed at Rp14,525 per USD. March 2021 inflation fell by +0.1% MoM (previous month at +0.3% MoM), elevating annual inflation to level of +1.4% YoY (previous month at +1.6% YoY). Trade balance for February 2021 recorded surplus USD1,964m (previously at surplus USD2,100m). We're focusing on companies and sectors with strong earnings growth and those which will benefit from advancing domestic economy. Therefore, we overweight oninfrastructure, sector while neutral on miscellaneous industry, finance, trading, agriculture, property, sector and underweight on basic industry, consumer, and mining sector.
