Investment Objective

Maximize investment return in medium to long term through investments in domestic debt and money market instruments in accordance with the legislation in force in Indonesia.

Fund Manager's Comment

The Fund's net performance for the month of September 2025 came in positive at +0.73%. Currently, portfolio duration is 7.12 yr. IDR denominated Government bonds prices fell in September 2025. This is indicated by the increase in yield of 10 year benchmark from 6.36% to 6.37%. On the other hand, the yield of 15 year benchmark saw the steepest increase of 4 bps. Rupiah depreciated against USD from 16,500 to 16,665 per USD. Annual inflation rose to 2.65% YoY compared to 2.31% YoY in the previous month. Foreign ownership in government bond reached 14.14% of total government bonds, dropped from the previous month level at 14.87%. Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under current rate cut cycle and supported by better liquidity as a result of lower SRBI Issuances by Bank Indonesia. Additionally, although current global financial markets volatility is moderating, we remain nimble and continue to monitor the situation and adjust our allocations as needed.

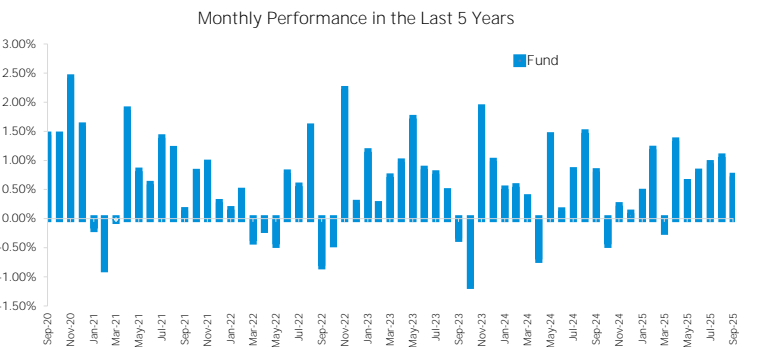
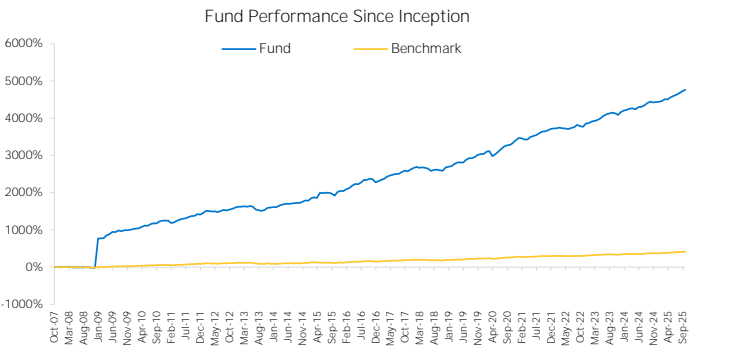
