Sharia bond prices tend to fall in February 2024. This is indicated by the rising yield of the 10-year benchmark PBS029 from 6.57% to 6.65%. 5-year benchmark price, PBS023, at the end of February 2024, has fallen, as indicated by risen yield, from 6.60% to 6.62%. Sharia bond portfolio duration is 6.4yr.


