Investment Objective

Obtaining optimal investment growth over the long term through investment in marketable securities available in the Capital Market and Money Market, consisting of equity securities issued by corporations engaged in the infrastructure sector and the consumer sector and other sectors that support the infrastructure sector and the consumer sector as well as money market instruments.

Fund Manager's Comment

During the month of January 2026, IDXA80 declined by 3.39 points (-2.56%) to 129.17. The leaders were AMMN, MDKA, ANTM, BBRI and TLKM. On the other hand, BRPT, BBCA, BUMI, PTRO, and ASII were the laggards. On the sectoral basis, basic material, transportation, and consumer cyclical sectors were the best performers, while miscellaneous industry, infrastructure, and energy were the worst performers. In January 2026, foreign recorded net buy of IDR 7.9tn from Indonesia's stock market. From the commodity market, oil price rose to USD 70.69/barrel, meanwhile, gold price increased by 8.59% to USD 4,714/oz. The Rupiah exchange rate weakened by 0.57% from 16,690 per USD to 16,785 per USD. Annual inflation increased to 3.55% YoY from 2.92% YoY in the previous month. Trade balance in December recorded surplus of USD 2.5 bn (surplus in the previous month was at USD 2.7 bn). BI rate by end of January 2026 was unchanged at 4.75%.



