Fund Manager's Comment

In May 2025, MSCI Asia Pacific Islamic ex Japan Index (MIAPJ) rose 3.55% as US and China agreed to temporarily slash import tariffs. South Korea became the best performer, supported by strong performance by Doosan Enerbility Co. Ltd., which recently won USD250 mn Saudi gas power plant deal. Information Technology sector led the market as concern towards Trump's import tariff directed at IT companies diminished . On the other hand, healthcare sector was the worst performer among the region, dragged by Sun Pharmaceutical Industries as the company concluded the acquisition of Checkpoint Therapeutics, Inc for USD355 million.


