Investment Objective

Maintain the investment value and obtain a level of return in accordance with the level of risk acceptable in medium term through investments in fixed-income Debt securities and can invest in equity Securities and/or Money Market Instruments.

Fund Manager's Comment

The Fund's net performance for the month of February 2025 came in positive at 1.03%, underperforming the benchmark by 36bps. IDR denominated Government bonds prices generally rose in February 2025. This is indicated by the yield of FR103 (10 Year benchmark) decreased from 6.97% to 6.90%. In addition, the yield of 5 Year benchmark, FR104 decreased from 6.84% to 6.73%.

The Rupiah depreciated against USD from previous level of 16,305 to 16,596 per USD. Inflation in February 2025 stood at -0.48% MoM, compared to previous month at -0.76% while annual inflation stood at -0.09% YoY with the previous month at 0.76%. Foreign ownership in Government bonds rose from IDR 881Tn to 890Tn, thus foreign investors currently have approximately 14.38% of total Government bonds. Currently, IDR bond portfolio duration is 6.90 yr. Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under the current rate cut cycle.

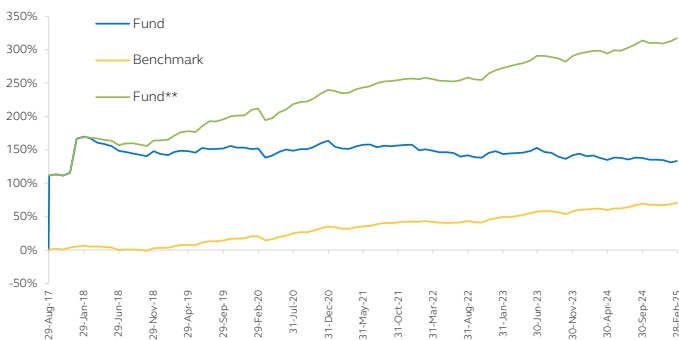

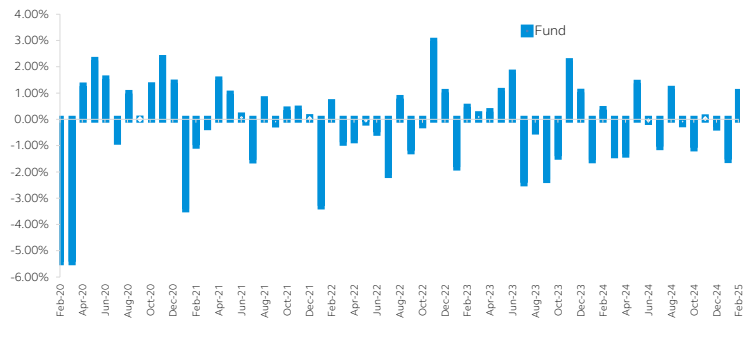
