## Fund Manager's Comment

The Fund's net performance for the month of December 2025 came in positive at +0.98%. Currently, portfolio duration is 5.013 yr. IDR denominated Government bonds prices rose in December 2025. This is indicated by the decline in yield of 10 year benchmark from 6.32% to 6.09%. On the other hand, the yield of 5 year benchmark saw the steepest decline of 29 bps. Rupiah depreciated against USD from 16,660 to 16,769 per USD. Annual inflation rose to 2.92% YoY compared to 2.72% YoY in the previous month. Foreign ownership in government bond reached 13.39% of total government bonds, rose from the previous month level at 13.36%. Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under current rate cut cycle and supported by better liquidity as a result of lower SRBI Issuances by Bank Indonesia. Additionally, although current global financial markets volatility is moderating, we remain nimble and continue to monitor the situation and adjust our allocations as needed.

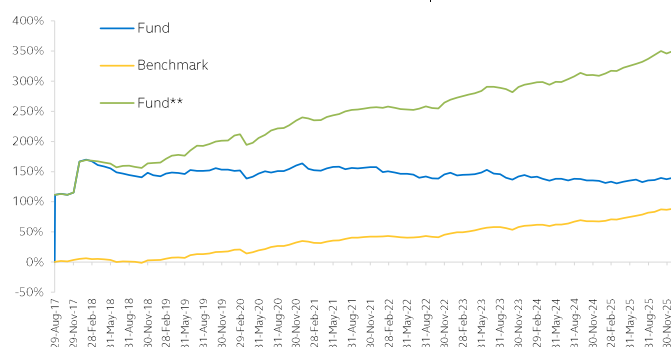

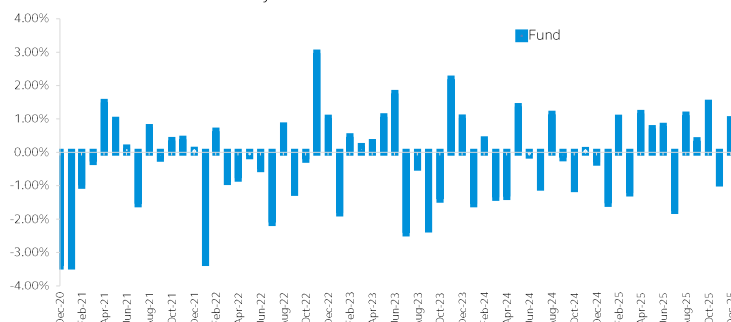
