## Fund Manager's Comment

Sharia bonds prices tend to fall in April 2024. This is indicated by the yield of 10-Year benchmark PBS029 that rose from 6.59% to 6.64%. Yet the yield of 5-Year benchmark PBS023 at the end of April 2024 was down from 6.65% to 6.61%. Sharia bond portfolio duration is 5.67yr.

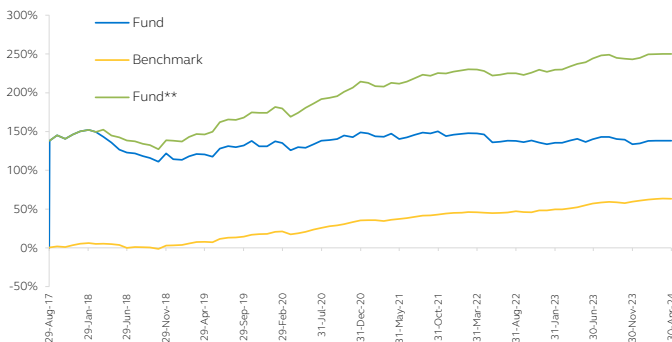

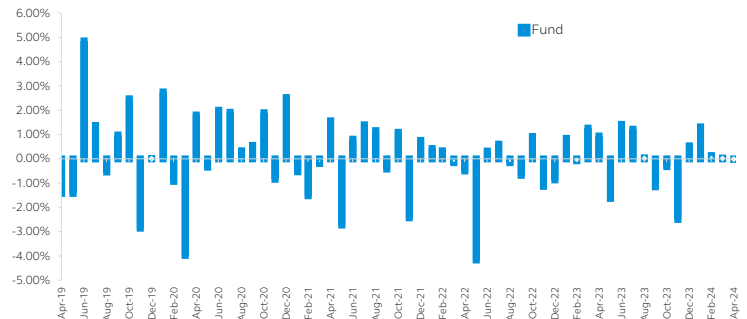
