Investment Objective

Preserve investment value and gain a level of return in accordance with the tolerable level of risk in medium term through investments in Sukuk and/or Shariah Government Securities, as well as being able to invest in other Shariah-compliant securities in accordance with Shariah Principles in the Capital Market.

Fund Manager's Comment

The Fund's net performance for the month of July 2025 came in positive at +0.97%. Currently, IDR bond portfolio duration is 4.34 yr. IDR denominated Government bonds prices rose in July 2025. This is indicated by the decline in yield of 10 year benchmark from 6.84% to 6.57%, a steep decline of 27 bps. Rupiah depreciated against USD from 16,290 to 16,455 per USD. Annual inflation rose to 2.37% YoY compared to 1.87% YoY in the previous month. Foreign ownership in government bond reached 14.59% of total government bonds, dropped from the previous month level at 14.60%. Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under current rate cut cycle and supported by better liquidity as a result of lower SRBI Issuances by Bank Indonesia. Additionally, we are also aware that the global financial markets continues to be volatile and we therefore continue to monitor the situation and adjust our allocations as needed.


