Fund Manager's Comment

The Fund's net performance for the month of November 2025 came in negative at -0.33%. Currently, portfolio duration is 4.3 yr. IDR denominated Government bonds prices fell in November 2025. This is indicated by the increase in yield of 10 year benchmark from 6.08% to 6.32%. On the other hand, the yield of 5 year benchmark saw the steepest increase of 39 bps. Rupiah depreciated against USD from 16,630 to 16,660 per USD. Annual inflation declined to 2.72% YoY compared to 2.86% YoY in the previous month. Foreign ownership in government bond reached 13.38% of total government bonds, dropped from the previous month level at 13.58%, Going forward, we remain positive on the local bonds market. We expect this fixed income fund to benefit under current rate cut cycle and supported by better liquidity as a result of lower SRBI Issuances by Bank Indonesia. Additionally, we are also aware that the global financial markets continues to be volatile and we therefore continue to monitor the situation and adjust our allocations as needed


