- a. companies and/or organisations that act as our agents, affiliates, business partners, subsidiary(ies), shareholders and its related companies and/or professional advisers;
- b. companies and/or organisations (including that but not limited to custodians, trustees, distributors, brokers) that assist us in processing and/or otherwise fulfilling transactions that you have requested;
- c. companies and/or organisations that assist us in providing value added services that you have requested;
- d. your advisers and/or agents (including but not limited to brokers, accountants, auditors, lawyers, financial advisers or other professional advisers) where authorised by you;

We will otherwise treat your personal information as private and confidential and will not disclose your information to anyone outside the Principal except:

a. where you have given permission;

- b. where we are required or permitted to do so by law;
- c. where required or authorised by any order of court, tribunal or authority, whether governmental or quasigovernmental with jurisdiction over Principal;
- d. where we may transfer rights and obligations pursuant to our agreement(s) with you; and/or
- e. where we are requested or required to meet our obligations to any relevant regulatory authority (whether in or outside Indonesia).

Security of Your Personal Information
